INTRODUCTION

Ner Israel Rabbinical College is required to provide regular reporting to the U.S. Department of Education (ED) on the use of funds authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA). Funds received by Ner Israel Rabbinical College under the CRRSAA were authorized by Congress and signed into law by the President on December 27, 2020. The information noted below is intended to not only meet the reporting requirements of the CRRSAA but also provide information to our college community regarding Ner Israel's use of the student grant portion of the Higher Education Emergency Relief Fund (HEERF).

Ner Israel Rabbinical College received federal funding under the CRRSAA to provide financial aid grants to students that can be used toward any component of the cost of their attendance or emergency costs due to coronavirus such as tuition, food, housing, healthcare (including mental healthcare) or child care. The Department of Education has directed Ner Israel Rabbinical College to "prioritize grants to student with exceptional need, such as students who receive Pell Grants.

ACKNOWLEDGMENT OF FUNDING AND CERTIFICATION

Ner Israel Rabbinical College acknowledges that the institution's authorized representative signed and returned to the Department of Education the Recipient's Funding Certification and Agreement to Students under the CARES Act. The required Certification and Agreement documents remain in effect from the original issuance under the CARES Act process. Under the CRRSAA, Congress calculated amounts for the HEERF II funding for each institution of higher education. Ner Israel Rabbinical College was awarded \$114,934 to be used for financial aid grants to students; and \$227,695 was awarded for institutional use in responding to the COVID-19 crisis.

The total amount of funds that Ner Israel Rabbinical College has received from the Department pursuant to Ner Israel's Certification and Agreement [for] Emergency Financial Aid Grants to Students is \$536,929, cumulatively. Under the CRRSAA, Ner Israel Rabbinical College was allocated \$114,934, respectively. The total amount of emergency grants distributed to students under the CRRSAA Act from May 14, 2021 through the close of business on Sept 30, 2021 is \$114,934.

#### ARP STUDENT ELIGIBILITY CRITERIA

The process by which these funds will be disbursed is as follows. A base grant of \$700 was established. Students that had received a PELL grant, or other exceptional need were award a "double grant" of \$1400. Married students, due to their higher Cost of Attendance, were granted \$1050. A student that was only enrolled for one semester was granted a portion of the \$700. This was done by combining the CRRSAA and ARP checks into one check to streamline the check writing process and get the money to the students faster.

#### TOTAL STUDENT AWARDS MADE

The total number of Ner Israel Rabbinical College students who have received an emergency grant under the CRRSAA from Dec 27, 2020 through Sept 30, 2021 is currently 535 students with a total of \$114,934 being awarded. Approximately, 550 students may have been eligible for these grants.
